ENHANCING COLLECTIVE IMPACT

Our organisation has consultative status with the United Nations Economic and Social Council (ECOSOC), the International Labour Organization (ILO) and the United Nations Educational, Scientific and Cultural Organization (UNESCO). This enables us to advocate up to the highest levels, to promote the right to quality education of all girls and women. We are also a member of CHARGE (Collaborative for Harnessing Ambition and Resources for Girls' Education).



INCREASING IMPACT IN LATIN AMERICA

GWI held a capacity building workshop in Mexico City, for our members in Latin America, on building membership and visibility to increase collective impact. Members from across the region participated. Here Jessica Nava, a member of the Mexican Federation of University Women, shares her experience:

“The workshop was a great experience and I learnt a lot. Before the workshop I wasn't sure how I could contribute to the Federation or work with other members to make a difference. I learnt how to combine ideas and different expertise in a group to create a project, and the skills and tools needed to make the project successful. My group created an action plan for a mentoring project which we have since set up. I feel much more involved and connected with other members.”



We run projects, internationally and in-country, with our national federations and associations (NFAs) and other partners. An important part of our work is supporting and strengthening our national affiliates. Our activities include:

- Training and capacity building for our members online and in-country
- Advocacy for the lifelong education of girls and women
- An international triennial conference centred on education, gender and human rights
- Providing fellowships to post-graduate women mainly in the areas of study most closely aligned to our mission
- Assisting graduate women, who have been displaced as a result of war, political upheaval, natural disaster or other serious emergencies, in re-training
